Position Objective: This position is responsible for the establishment of Intensive Therapeutic Care (ITC) services for

children and young people within the Queanbeyan and Goulburn regions. The position requires the commitment and ability to transition existing services to new therapeutically enhanced service models and hold with the mission of supporting young people to heal from past traumas to achieve positive

socially and economically inclusive futures.

- Position Responsibilities: Manage the implementation of Intensive Therapeutic Care Services for young people focused on the 10 Essential Elements of Therapeutic Care for the NSW Care Framework.
 - Provide leadership in the implementation of the Sanctuary Model of Trauma Informed Care across ITC Services.
 - Manage the ITC Services according to the NSW Legislative requirements and the NSW Child Safe Standards for Permanent Care.
 - Lead the implementation of ITC Services through the establishment of Care Teams and Case Planning processes for children and young people in consultation with Therapeutic Specialists within the ITC Services.
 - Develop and maintain links with key stakeholders, government departments and the community to ensure wrap-around supports and an integrated approach to service provision for children and young people. Provide strategic leadership in the development of ITC Services in accord with service contracts and service delivery requirements.

- Provide reflective supervision to St Saviours/Anglicare ITC House Managers. Facilitate the ongoing therapeutic professional development and training opportunities for all ITC staff.
- Monitor and review quality performance outcomes for St Saviours/Anglicare ITC Services.
- Monitor budgets and complete financial records and reporting requirements for St Saviours/ Anglicare ITC Services.
- Provide support in development and monitoring of all ITC service budgets.
- Identify, mitigate and report operational and financial risks.
- Participate in afterhours emergency On Call duties for St Saviours/Anglicare ITC services.
- In addition to these responsibilities and duties you are expected to undertake other responsibilities and duties as they may from time to time be assigned by Anglicare.
